**FEES:** A picnic permit fee and a damage deposit will be charged to all permit applicants. Persons applying who are residents of Lemont Park District will be charged a permit fee of \$40.00 without alcohol and \$75.00 with alcohol. Persons applying who are non-residents of Lemont Park District will be charged a permit fee of \$60.00 without alcohol and \$95.00 with alcohol. A refundable deposit of \$25.00 will be charged to all permit applicants. These fees will help defray the cost of the portable toilet units and the ever increasing amount of clean up needed for these areas.

**THE USE OF GLASS BOTTLES/CONTAINERS IS PROHIBITED IN ALL OF THE LEMONT PARK DISTRICT SITES!!!**

**ALCOHOL PERMITS:** If alcoholic beverages (alcohol beverages consists of beer and/or wine) will be consumed, please fill out an Alcohol Permit. Permit holders are subject to the rules, regulations and policies of the Lemont Park District.

Moon Walks, Dunk Tanks and other means of entertainment require Park approval prior to the event. Groups hosting these type of attractions will be required to provide the Lemont Park District with a Certificate of Insurance from the amusement company naming the Lemont Park District as Additional Insured.

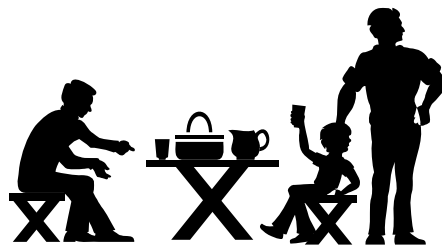

## ADDITIONAL PICNIC INFORMATION

1. All parks close at dusk.
2. Picnics must conclude and exit park premises by **9:00PM**.
3. No glass bottled containers are permitted.
4. Alcohol consists of beer and wine only.
5. Pets must be on a leash.
6. When renting a grove or picnic area, you are reserving just that area. Since our parks are public property, all other facilities such as tennis courts, basketball courts, softball fields, etc. must remain open to the public.
7. Your are picnicking behind our neighbors, please remember to be considerate.
8. Designate a drive – we want to see you return next year.

10. Centennial Pool is available for private evening rentals or picnickers can use the pool in the afternoon for the daily walk-in fees.
11. Any cancellations due to inclement weather will be reviewed by park administration following contact within 48 hours after planned event.
12. All other cancellations are subject to a \$25.00 service fee.
13. Additional port-a-potties are available at additional fees.
